effective 1 July 2022



Residential tariffs (regulated)

Tariffs applicable to customers using less than 750MWh of electricity per year for premises used for residential purposes. These tariffs also cover:

- Electricity used on vacant land zoned for residential purposes
- Living premises of retirement villages (must be separately metered).

'Regulated' tariffs are effective 1/7/2022 – 30/6/2023.

Business tariffs (regulated)

Tariffs applicable to customers using less than 750MWh of electricity per year for premises used for non-residential purposes, including:

- Electricity used on vacant land zoned for commercial purposes
- Temporary supply (i.e. for building and construction purposes)
- Motels, hotels, serviced apartments and any form of temporary accommodation
- Shops, offices, warehouses and industrial/ manufacturing plants
- Mining enterprises
- Farms
- Excluding Public Benevolent Institutions

Public Benevolent Institution tariff

Tariff applicable to charitable organisations recognised by the Australian Charities and Not-for-profits Commission (ACNC).

Feed-in-tariff rates

To be eligible to receive these feed-in-tariff rates, all PV Units installed at the premises, must not be equal to or greater than 30 kVA and customer must not consume equal to or more than 750,000 kWh per annum.

Premium feed-in-tariff rates

The Northern Territory Government announced key changes to Jacana Energy's solar feed-in tariff (FiT) rates.

As of 1 July 2022 customers who have received the Premium feed-in tariff for four years or more, will be changed to the Standard feed-in tariff (9.13 cents per kilowatt hour incl. GST).

Premium rates are available to solar customers who lodged their applications to Power and Water by midnight 14 April 2020 and whose installer can demonstrate that works were committed to, in writing, prior to 5th April 2020. Approval to export electricity into the grid will continue to be subject to the technical requirements and approval of the network provider, Power and Water Corporation.

Standard feed-in-tariff rates

These rates are available to:

- new solar customers who apply to install a solar system after 5 April 2020;
- existing solar customers who modify their rooftop solar system after 5 April 2020.
- customers who move to a property with an existing solar system, even if the previous occupier received the Premium tariff.

Commercial default tariffs (unregulated)

Tariffs applicable to customers using 750MWh to 2,000MWh of electricity per year for premises used for non-residential purposes and who have not entered into a negotiated contract, including:

- Electricity used on vacant land zoned for commercial purposes
- Temporary supply (i.e. for building purposes)
- Motels, hotels, serviced apartments and any form of temporary accommodation
- Shops, offices, warehouses and industrial/manufacturing plants
- Mining enterprises
- Farms
- Excluding Public Benevolent Institutions
